There is no Treasurer now but hopefully one will be appointed in the August meeting.

During the Business Meeting it was reported that the Mental Health Consultation has 2 SDCC members working on it. The Stonehaven Medial Practice has asked if the SDCC could host another public meeting in Sept/Oct of this year.

RC reported that there has been difficulty in getting folks to join the Portlethen	
Community council and because of this it is looking likely that it will fold. Cllr Dickinson	
reported that it used to be a Participatory Budget play standard meetings. Crathes is in	
the same position. Officers from the Aberdeenshire council are willing to assist. As we	
move to more community empowerment the communities are being asked if they want	
to be involved. Maybe fatigue is an issue as it's been so active in the past? The	
communities themselves have to drive this forward. People need to know that they are	
been listened to and can see actions happening. Cllrs are making the point that the	
council needs to be involved to help the communities become empowered. RC	
explained the process they have and perhaps the involvement of the Area Manager	
would have helped?	
DS – if the public can see things have been done then that gets people on side if they	
can see tangible results. John Emslie, a volunteer from KAMCAB gave a talk about the	
services that they offer and their new office. All felt this was a very informative talk. RC	
offered thanks to STP Ops for the work that they have done that has allowed the	
KAMCAB to move into the new office.

Wind Farm Funds – St Johns Hill, Meikle Carew, all open. There have been several	JL
enquiries about Mid Hill – this is a Fred Olsen wind farm. Not sure how the money will	
be distributed. Issue of transparency of this fund was raised. Midhill have lodged	
planning permission for more turbines in the Drumtochty Forest area. Offshore	
Kincardineshire which will be 7 – there is 1 just now. Not sure if there is any community	
payback scheme in operation as there is no obligation to do this for offshore farms.	
RC reported that Fred Olsen Renewables will be holding a series of public consultations	
in the area soon.
