# BERVIE BRAES ROAD (DS) (decision required on who will take this project over)

No further responses from Martin Kitt-Hayes.

The Bervie Braes Road Project is mentioned in the STP's Business Plan 2012 – 2015 and was also included in the Community Plan. There was also a comment in PfR that there should be better access for walkers and cyclists on Bervie Braes.

### PLAN B (DS, WE, DF, MW) (decision required on who will take this project over)

Second meeting with Aberdeenshire Council and SDCC held and Recreation Grounds discussed at last SDCC meeting.

The Plan B Project has been initiated as it was in STP's Business plan **SPORT AND LEISURE FACILITIES AT THE RECREATION GROUND SITE** – investigating the possibility of improved facilities at this site, alongside reviewing alternative locations. There were also a number of comments made by residents in the PfR exercise about this area of Stonehaven.

# FUTURE OF STONEHAVEN COURT HOUSE BUILDING (DF)

The Open Days on Friday 4<sup>th</sup> December (16:00 to 21:00) and Saturday 12<sup>th</sup> December (10:00 to 15:00) were a great success with over 500 people coming into the Court Building to look at the Building, watch the Mock Trial, listen to some live music and singing, visit the craft stalls and give some feedback on what they thought the Building could be used for. The information received will be added in to the Business Plan.

We are now waiting for the completed Conservation Report and the Business Plan will be completed as far as possible, for discussion at the January Trustees meeting (5<sup>th</sup> January 2016).

All the condition surveys of the building are now complete, and reports are available on the website.

### **IMPROVING OUR TOWN CENTRE (JS)**

This project commenced due to comments that were made by residents at the PfR exercises. Comments were made about Town Centre signage, the appearance and upkeep of some of the buildings in the Centre and the seagull nuisance.

### FORMER GAS WORKS SITE (MW)

This project resulted from comments made in the PfR exercises about the lack of parking in Stonehaven in general and specifically the lack of parking in the Auld Toon during busy times.

### LAND TRAIN (MW)

The Land Train picked Santa up from Stonehaven Harbour on 12<sup>th</sup> December and took him and some children who were competition winners to Michies Chemist, where he'll be in his grotto for December.

The Economic Impact Assessment showing the benefit of the Land Train to Stonehaven has been started and will be available early next year. After this report the Economic Impact Assessment of the QEII Caravan Park will be commenced.

Stonehaven Town Partnership have been awarded £87,419 from the Coastal Communities Fund, Big Lottery Fund. This funding will be used to purchase an additional carriage for the Land Train for the 2016 season as well as providing continued salaries for the Land Train Drivers and Conductors as well as the Project Development Officer's position up until December 2016.

We will also be looking for additional drivers and conductors for part time positions next year.

As above this project came about by comments that were made during the PfR exercises that the STP undertook in 2012. It also fits in well with the STP's SCIO objectives by assisting in the regeneration of Stonehaven by bringing tourists into the Town from Dunnottar Castle and was mentioned in the STP's Business Plan of 2012 – 2015 to ease parking congestion in the Town
