

# **PROJECT UPDATE**

## **QE2 CARAVAN PARK (DF)**

Boundary vegetation planting has been promised in November. Lease and invoicing still outstanding. DF to meet with Willie Munro and Graham Wall (Aberdeenshire Council Landscape Service Manager) in next couple of weeks.

## **OAITS (MW)**

Nothing further to report.

## **ALL WEATHER FACILITY (DS)**

Draft lease provided by Aberdeenshire Council. Tender document should be finalised on Wednesday 17<sup>th</sup> Sept and issued shortly thereafter. Application for SCAWSF committee to be Company Limited by Guarantee now with Companies House.

## **TOWN HOUSE/CLOCK TOWER (DS)**

Project running behind schedule due to building warrant delay and stonework problems. Should be open in the next few weeks.

## **LAND TRAIN (MW)**

Began running in week beginning 16<sup>th</sup> August. Proved to be very popular attraction in Stonehaven. Relying on "volunteers" as well as paid conductors as some of the initial conductors have now returned to college/uni. Part of the cost of insurance has been claimed from CCF. Intention is to run the Land Train until after the October holiday and to have shorter trips running in December (Santa Express).

## **IMPROVING OUR TOWN CENTRE (JS)**

Jim Stephen has requested help to buy tools/equipment for the Horizon Group. Project plan has been suggested. Research is underway into a number of initiatives around the Town with IM's assistance.

## **GAS WORKS CAR PARK (MW)**

Aberdeenshire Council and STP are waiting for Ryden's to arrange a meeting to discuss further.

## **HARBOUR DEVELOPMENT (DS)**

Wynne Edwards sent request for Quote (RFQ) to 3 companies with deadline for return of 30<sup>th</sup> September. Initial meeting held with Aberdeenshire Council with next meeting planned for 26<sup>th</sup> September.

## **BERVIE BRAES ROAD (DF)**

No action taken by Aberdeenshire Council. Work on pavement and cycle path planned and will take place once road is closed for winter.

## **ENERGY CO-OPERATIVE (WE)**

Draft report written by Wynne Edwards to be discussed with trustees.

## **COASTAL COMMUNITY FUND**

Part of Land Train insurance cost claim has been submitted.
